Mr. President,

CONGRATULATIONS + our plea.

On behalf of the refugees and displaced persons from the District of Kyrenia in Cyprus, we wish to congratulate you on your election to the Presidency of the United States. We also wish you a successful term of Governance, for the benefit of the American people, as well as for the people of the World.

Your campaign messages, as well as your inauguration proclamations give hope, not only to the Americans but to the whole World.

It certainly gives hope to us, being the victims of aggression and brutal behavior of a ruthless, neighbouring country, namely Turkey. We have been displaced by military force and a wave of violence against civilians, which lead to our Ethnic cleansing and the appropriation of our land in the occupied area of Cyprus. Mass transfer of Turkish settlers followed our expulsion, filling the population gap we left behind, in violation of International Law. (War Crime).

Following the invasion, occupation, the ethnic cleansing and the mass settlement of the occupied areas, Turkey declared the occupied area of Cyprus, a separate Independent Turkish State. Rightly so, the United Nations Security Council declared this, as an illegal act and called for its dismissal, with Resolutions 541 & 550.

Today our leaders, facing the extreme Turkish intransigence and also being under unlawful pressure from Western Countries including American administrations before you, are conceding to compromise with World Law and Order and submit to the Turkish demands, to legalize the De-Facto situation in the occupied areas, into a DE-YURE State. This crime is intended to be committed under the cover-up of Bizonal Bicomunal Federation, i.e. The creation of a separate State, the conditions for which did not exist before the Turkish invasion. It was the main aim of the invasion: to create the conditions for BBF.

If this is allowed to happen, the Cypriot refugees and displaced people shall permanently be deprived of their Human Right to return and be reinstated in their ancestral land, in their homes and on their property. The brutal violation of Human Rights by Turkey in 1974 shall then be rewarded. 33% of the population of Cyprus, a percentage equivalent to 100 plus

million Americans, shall permanently be unjustifiably victimized, so that Turkey and other foreign interests could be satisfied.

Mr. President, encouraged by your proclamations so far, including concern about Human Rights in countries around the World, we shall be looking for your attention towards our case. We shall anticipate your positive intervention, so that, the external pressure is relieved off the shoulders of our leaders and so that they are encouraged to seek justice for Cyprus and our people, Greeks, Turks, Armenians, Maronites and Latin. **Justice for Cyprus and its people, is a one-way street, leading to the liberation of Cyprus and the restoration of International Law and Order so brutally violated in 1974 and unjustifiably lasting till today.**

International Law dictates:

- Turkey must terminate its occupation of Cyprus by withdrawing all its troops from Cyprus, thus restoring the Independence, territorial integrity and Sovereignty of the Cyprus Government all over Cyprus.
- Turkey must remove all illegal Settlers from the Island
- This development shall allow the restoration of the Human Rights of all Cypriots by normalizing the violated demographic character of Cyprus.
- Then, under the auspices of the United Nations and your enlightened leadership and guidance as a World leader, we, the Cypriot people through the specified Democratic procedure, to re write the Constitution of Cyprus so that democracy can prevail in its full sense: Majority rule and the rights of all minorities fully safeguarded

Mr President, such a road - map shall be beneficial to both countries. It will certainly help consolidate the strategic partnership currently developing between our two countries in our region and boost your stature as a world leader.
