Dear Mr. Menendez,

Welcome to Cyprus.

The people of Cyprus are grateful for your consistent condemnation of the Turkish occupation of part of Cyprus and your efforts in favour of restoring the freedom and independence of our country, as well as restoring the active co-operation of our two countries for the benefit of our people, for peace and security in this part of the World.

We appreciate your firm position on Famagusta, condemning the renewed Turkish provocations there and supporting the implementation of the UN Security Council Resolutions on the matter.

Simultaneously we wish to declare our strong disagreement to your expressed support to the solution of Bizonal Bicomunal Federation. Please be reminded Mr. Menendez that, the conditions of today, justifying calls for Bizonal Bicomunal Federation, are the outcome of:

- the Turkish invasion,
- occupation,
- ethnic cleansing of all of us, from the occupied area,
- "importing" thousands of Turkish settlers from the Turkish mainland to replace us,
- Forceful movement of the Turkish Cypriots into the occupied area, naturally being until the day of the invasion, dispersed all over the island,.

Also Mr. Menendez please be reminded that, we the displaced people from the occupied area of Cyprus constituted in 1974 the 85% of the population there and we were the owners of 85% of the land there. These facts show the dimension of the Humanitarian Problem faced in Cyprus, which cannot be solved with BBF solution.

Therefore, we stress that a BBF solution shall be rewarding for the aggressor, for the military invasion, occupation and gross violation of Human Rights. It will be rewarding for the war crimes committed by Turkey against us and Humanity.

America on a daily basis speaks for Human Rights and not only condemns countries violating them, but adopts policies and practices exercising pressure to respect them. With this in mind, we cannot accept the American support for BBF solution to the Cyprus Problem. We


