Mr Guterres,

You are asked to listen to: The forgotten, by the Caretakers of the UN, refugee and displaced population of occupied Cyprus

We repeat our welcome to Cyprus and refer to our letter refer. AK802026 sent to you on the 23/7/2026, hereby attached, which supposedly did not reach you in New York before you left for Cyprus.

We are sure you are aware of all the details of the Cyprus problem. However we feel obliged to remind you some of the tragic facts of the Problem from the 20th of July 1974 until the present date. The facts are a long line of illegal and criminal deeds by Turkey against the Cyprus Republic and our people:

- 37% of the sovereign land of the Republic of Cyprus is occupied following an illegal military invasion by Turkey
- 33% (200000 in 1974, 320000 today people) of the population of the Republic of Cyprus has been ethnically cleansed from the occupied area, by Turkey. This war crime and crime against Humanity constitutes a Humanitarian tragedy the dimensions of which can be realised by comparing figures of 33% of the population of the following countries:
 - England –approximately 23000000
 - France-- >> 23000000
 - Germany-- >> 27000000
 - Italy--- >> 20000000
 - USA-- >> 115000000
- During the 52 years of occupation Turkey systematically continued to violate the UN Charter, by:
 - Colonising the occupied area with thousands of Turkish, European and other settlers
 - Committing criminal brutal acts against the innocent population of the occupied area: systematic rape, torture, beating, killing and taking prisoners who are missing still today.
 - Undertaking illegal partitioning acts which the UN Security Council Resolutions 541 & 550 declared non-valid and called for their withdrawal
 - Desecration and destruction of holy places, as well as our cultural heritage
 - Vandalism and destruction of places of worship and cultural heritage

- **Illegal Commercial exploitation of our properties in the occupied territories**

These are undeniable facts.

Therefore we consider it inconceivable that Turkey deserves to be rewarded with a compromise in Cyprus, called B.B.F. at the expense of the Sovereign Rights of the Republic of Cyprus, Member of the UN and the European Union, **as well as at the expense of the Human Rights of the indigenous population of the Republic of Cyprus.**

Talking for 52 years for a solution of Bizonal Bicomunal Federation and by trying today with your visit to conclude the unlawful compromise, **Turkey is rewarded** for all the above crimes, at the expense of the Cyprus Republic and the Cypriot people of all origins and religions.

The UN which was the hope of small Nations (States and people) should not be allowed to be discredited in the eyes of the World Community with such a compromise at the expense of a small country like Cyprus.

Dear Mr Secretary General it is not fair for you at the end of your Service to become part of such a development.

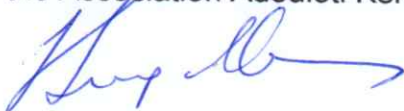
Please listen to the voice of the civil society your representatives refused to listen to, the last 52 years: the victims of the invasion and occupation, the refugees and the displaced people of Cyprus.

Remind your Interlocutors here in Cyprus today, about the UN Charter and pursue a course of action which should lead to:

- ❖ The freedom of Cyprus by terminating the occupation
- ❖ The removal of all the settlers, who are responsibility of Turkey alone.
- ❖ The withdrawal of all the Turkish troops
- ❖ The restoration of Independence and territorial integrity of Cyprus Republic
- ❖ The reinstatement of all cypriot refugees and displaced people back to their homes and property, back to their towns and villages. Their Human Rights and freedoms fully restored to what they were in 1974.
- ❖ Cyprus to become a truly democratic country under a new democratic Constitution truly free and a guarantor of peace in the region.
